Sir John is rated the 'Number One Business Coach' by The Independent newspaper and as the person having had the most impact on the coaching profession by the UK Association of Coaching. He has written five books of which *Coaching for Performance* is the best known, having sold over 500,000 copies in 17 languages.

One reason that companies listen to Philippa is that she has worked in business for 25 years including several senior management positions. She serves as a non-executive director of the Institute of Directors and was recently appointed by BAE Systems to the four-person committee chaired by Lord Woolf, the former Lord Chief Justice, to examine the company's ethical business conduct.

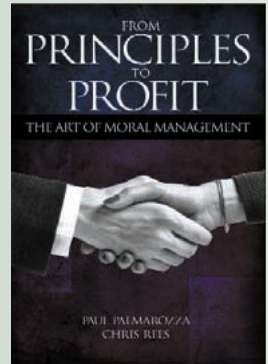
